**RAISING AWARENESS ABOUT LIFE INSURANCE**



Each September since 2003 has been designated as Life Insurance Awareness Month. Like most awareness-raising campaigns, Life Insurance Awareness Month was created because there is an overwhelming lack of understanding of the product among the general public. Each year, the Life Insurance Market Research Association puts out the results from a recent survey, and unfortunately, the numbers they report continue to be discouraging.

A recent survey found that 76 percent of people polled did not have a personal financial advisor. Sixty-eight percent of that same survey group said their opinion of the current economic conditions was somewhat unfavorable or very unfavorable.

In other words, a majority of those surveyed were uncomfortable with the economy and the uncertainty it brings, yet they did not seek professional assistance. Maybe they spoke with their friends and family. Maybe they hoped the instability would go away on its own. Maybe they did not know to whom to turn.

If you fall into this category, please remember that as a member of the Knights of Columbus, you have a full-time, professional agent you can call your own. My primary responsibility is the care and service of your family's life insurance, retirement and long-term care needs. I'll answer your questions because I want your decisions to be informed ones. ## **GENERAL MEETING OF COUNCIL 1684 WEDNESDAY, JULY 13, 2011**

Thirteen members were present when the Council meeting for July was called to order at 7:48 p.m. by Grand Knight Bruce García. Brother Bruce lead the prayer and Pledge of Allegiance. Upon closing the meeting doors, Warden James Bauer verified membership cards.

The minutes taken by Acting Recorder Richard Rink from the June meeting were approved as corrected to show a \$650 to St. Vincent de Paul instead of \$500.

Under membership, the Financial Secretary read prospective member Sean Connolly's application for the second time.

The Grand Knight reported on the following items:

- A review of the Officers' Installation revealed that members thought that Council 1684 did a great job.
- Preparations for our Old Spanish Days booth in MacKenzie Park are right on schedule thanks to Brother Mark Weitstock. Members are encouraged to sign up for any of the four hour shifts from Wednesday, August 3<sup>rd</sup> to Saturday, August 6<sup>th</sup> by calling Brother Mark at 899-2729.
- The September 14<sup>th</sup> business meeting will come after a First Degree Exemplification.
- The September 28<sup>th</sup> social will feature barbequed tri-tip, hot dogs for the kids, bread, vegetable, and desert, topped off by a presentation about life in Kuwait by Brother Al Anglin and his wife Vangie Herrera.
- The October business meeting will come after a Second Degree Exemplification.
- The Knights Nite Out will fall on October 26<sup>th</sup> and is still reasonably priced at \$125 for the reverse raffle and two dinners.
- The Memorial Mass sponsored by Brother David Borgatello and his wife Louise is scheduled for November 9<sup>th</sup>.

Under communication, Brother Bruce read a request from Cherif Khoury from the St. Vincent de Paul Society requesting more money to support their efforts to take underprivileged children to summer camp. The discussion that followed showed \$650 in the budget, and no motion was made to change that amount.

Under the treasurer's report, the Council's July balance was \$6,859.02 after deposits of \$425.32 and withdrawals of \$3,532.32. The June dinner report shows 18 paid dinners at \$10.00 for income of \$320.00 (plus 18 guests at no charge). The food cost \$108.41 resulting in a profit of \$71.59 to the Council.

The Financial Secretary reported on six bills paid.

Under unfinished business, Brother Mark Weitstock is working on the new phone list. In addition, the Council expressed interest in exploring a slightly different investment policy some time ago and appointed an investment

committee during the May business meeting.

Two resolutions were presented by the committee and discussed with the idea of taking on some risk, but producing more money for the Council's charitable work.

Resolution 1: *Whereas the council wishes to continue its charitable donations in similar dollar amounts, and more funds will be needed in view of the new hall agreement from which we have rental expenses. Therefore, we propose that the council in addition to its own investment interest income, the investment income transferred to the council annually from the Home Association, up to 75% of the combined funds may be dispersed for Charity. This resolution supersedes the prior resolution governing the use of council investment income.*

Resolution 2: *Whereas the council wishes to diversify its investment funds to increase potential gains in a safe, conservative manner and the existing portfolio of laddered US Treasury securities does not adequately serve this wish, Therefore, we propose the councils investment portfolio be diversified to include up to 40% conservative non-treasury securities/funds, with the selection of same to be reviewed and approved by the councils Financial Secretary and Treasurer.*

Both resolutions were moved, seconded and carried unanimously.

Under new business, Brother Jim Garland urged all Third Degree members to attend the Exemplification for the Fourth Degree in Oxnard on November 5<sup>th</sup> at the Marriott Residence Inn. The fun filled weekend includes a welcome dinner, golf tournament, ladies' luncheon, Holy Mass, the Exemplification, and a banquet. Contact brother Jim for more information.

## *Pro-Life Report*

### **Hungary Adopts New Pro-Life, Pro-Marriage Constitution**

**E**ver since it became legal to kill unborn babies in the USA in the late '60s and early '70s, pro-lifers have longed to put anti-abortion wording into our Constitution. We can take heart from knowing that the Central European country of Hungary has given her unborn babies constitutional protection!

The Catholic Family and Human Rights Institute, which defends life, faith and family at the UN and other international forums, reports that Hungarian President Pal Schmitt has signed a new constitution that shields unborn babies' lives "from conception," and also defines marriage as between a man and a woman.

Pro-abortion groups are furious over Article 2, which declares, "The life of a fetus will be protected from conception." A pro-abortion New York City law firm, the so-called Center for Reproductive Rights, opposes the pro-life provision. So does Amnesty International, which has become an aggressive pro-abortion lobby.

Also, Amnesty International and a number of radical "gay" groups are upset that the new constitution doesn't protect homosexuals from so-called discrimination. Nor do they like the clause upholding the traditional definition of marriage, because it might prevent "same-sex marriages." They say this violates Europe's anti-discrimination standards. The Council of Europe, too, is scrutinizing the new constitution, which it dislikes.

But Roger Kiska of Alliance Defense Fund (a pro-life/faith/family legal group) is "overjoyed" at the new constitution, which he calls a victory for democracy, life, the family and Hungary. He brands as "shameful" the attempts to undermine Hungary's government, which he says the people overwhelmingly elected. "I hope that Hungary stays strong in its convictions," he comments, "because what is at stake, life and the family, are too high a price to pay simply to appease the bureaucrats in Brussels."

Hungary insists that her new constitution conforms to the European Union's fundamental charter of human rights and that it had to replace the outmoded Communist-era document that dated from 1949. The new constitution becomes law on January 1, 2012.

Let's give thanks to God and His Mother that Hungary, a nation with a long Catholic history, has enshrined the right to life of unborn babies in the fundamental law of the land. May our country follow her shining example!



## REMEMBERING THE DEPARTED MOTHER OF ONE OF OUR BROTHERS, JOHN KLINK

**M**ary Theresa Burke was born on April 25, 1918 to the parents of Patrick and Della Marie Burke of Casper Wyoming, Patrick and his brother M. J. Burke (Mickey) relocated their families from Ohio to Wyoming in the early 1900s where Patrick and Mickey founded the Burke Sheep Company. This company went on to be a highly successful enterprise in beef cattle ranching and sheep farming. Years following the early death of Patrick and Mickey's wife Anna, Mickey married Della.



Mary and her brother James would be raised in a devout Catholic home with step brothers/first cousins, Frank, Joe, John, and Bill Burke. Her brother James would later in life become Fr. James Burke, S.J. All have predeceased Mary.

On graduating from high school, Mary attended St. Mary's College in Leavenworth, Kansas where she earned a B.A. in English. In November 1940 Mary married Ralph Edmond Klink. Ralph had ranch holdings in Wyoming and Colorado with management of his properties being centered at the Flag Ranch in Laramie, Wyoming. With the ranch being nine miles from town, the wife of ranch owner provided many challenges for Mary.

In 1952, Ralph and Mary retired to California where they raised their four children, Fred, Jim, Anne and John. Ralph, who passed away in 2006, would become a long time Fourth Degree Knight of Council 1684. The Knights was not new to Mary since her father and brothers in Wyoming were also Fourth Degree knights. Mary would become an active member of the community being a co-founder of the Third Order of Carmelites at Mt. Carmel, the African Mission Circle, and Villa Majella. She was President of many Catholic organizations in Santa Barbara associated with her children's schools including Mt. Carmel, Marymount and Casa de Maria. She was the first President of the PTA of Bishop Garcia Diego High School and a longtime member of the Deanery of the Archdiocese of Los Angeles.

Mary is survived by her son Fred and wife Diana Doerr, grandson Danny and wife Courtney, great-grandchildren Patrick and Cady, granddaughter Michaela and husband Michael Caughlan, great-grandchild Stella; by her son Jim and wife Kathy Brugman, and granddaughter Mary Beth; by her daughter Anne Walsh, grandsons Michael Walsh, Brendan Walsh, and granddaughter Katie and husband Justin Straight; and her son John and wife, Patricia Wallace deBlank, and grandchildren Larry and Mary Theresa. She was predeceased by grandson Patrick Walsh in 2005 and son-in-law Kevin Walsh in 2010.

In her lifetime Mary placed a vivid imprint on the lives of family, friends, and people that came to know her. To quote her son John, "She was a great lady and remarkably devoted to the Church."
