

Remembering of Our Late Brother, Mario Borgatello SK



Mario (Hammer) Borgatello passed away peacefully on August 15th at the age of 95. He was born on April 18, 1918 in Santa Barbara, California, the youngest of five children born to Secundo and Josephine Borgatello. He graduated from Santa Barbara High School, Class of 1936. Mario and his buddies attended many dances in Santa Ynez Valley where he met the "love of his life" Peggy Saulsbury. He would come up from Santa Barbara every weekend just to dance with Peggy. After dancing their hearts out they decided to marry in September of 1941 at St. Joan of Arc Catholic Church in Las Vegas. Mario and his wife settled into a simple, but beautiful life together in Montecito where they raised their two beloved sons, David and Mario.

Mario and Peggy continued to make weekend trips to the Santa Ynez Valley tending to their ranch where he raised corn, fruits and vegetables for the family to enjoy! He also enjoyed many fishing trips to the High Sierras, driving to Las Vegas to try his luck at the tables.

The value of hard work was instilled in Mario by his parents from a very young age. Mario's father passed away when he was six months old, leaving his mother to raise five young children by herself. The young family was hard working and resourceful in their efforts to support themselves, leading to the creation of a small trash company. After graduating from high school, Mario worked full time picking up trash in Montecito. Later, along with his two sons, Mario created what is now known as MarBorg Industries. Mario had tremendous pride in his small company; adored watching his sons and numerous grandchildren carry on his passion and commitment for doing hard, honest work. His dedication to MarBorg was felt by numerous employees both past and present, affectionately referring to him as "Papa Mario." He continued to make his daily rounds at the facility; his last day being Monday, August 12th.

Community involvement was an important part of Mario's life. He joined the Knights of Columbus (Council 1684) at the age of 18, serving as an active member until his passing. Also, he was involved in the Santa Barbara Catholic High Booster Club, Montecito Lions Club, Meals on Wheels and the Poor Clares Monastery monthly adoration. He was generous with his time giving much to the community he loved.

Mario was a devoted and committed Catholic, his life reflecting the values of faith, honesty and humility. He was deeply involved in the formation and development of Our Lady of Mount Carmel Church. As a young man, he was an altar server at the first mass celebrated in the church in 1936. Mario and his wife, Peggy, were active parishioners of Mount Carmel finding many beloved friends among this community.

Close to Mario's heart was his loving family. He led his family with strong values and a commitment to each other. His legacy will live on through his two sons, David (Louise) and Mario (Judy), sisters, Laura and Ida Borgatello, Augusta Borgatello Lord (son Denny (Laura) Lord), sister's-in-law Nancy Barnett (Richard), Martha Saulsbury, Lynette Saulsbury, brother-in-law James Saulsbury (Darlene). He was blessed with seven grandchildren who affectionately called him "Papa" and 21 great-grandchildren, numerous nieces and nephews, and his canine pal, Bodie.

Mario was preceded in death by his parents Secundo and Josephine Borgatello, wife Peggy, brother Charles A. Borgatello and many other dear friends.

Funeral service, held at Our Lady of Mount Carmel Church, included recitation of the rosary on Sunday, August 18th, and a funeral mass on Monday, August 19th. Mario was laid to rest at Calvary Cemetery. He will be greatly missed by all that new him.

Gifts in his memory may be made to Bishop Diego High School Scholarship Fund, Mount Carmel School Scholarship Fund or to the donor's charity of choice. Funeral services were handled by Welch-Ryce-Haider.

GENERAL MEETING OF COUNCIL 1684
WEDNESDAY, JULY 10, 2013

Twelve members were present when Grand Knight Steve Romofsky called the Council meeting for July to order at 7:40 p.m. Upon closing the meeting doors, Warden James Bauer verified membership cards, and the Grand Knight led the opening prayer and Pledge of Allegiance.

The minutes of the June meeting were accepted as read.

Grand Knight welcomed a visiting Knight, Hans Verhaagen from Arizona.

The Worthy Grand Knight reported on the following items:

- August 14, Council meeting will hold first and second degree ceremonies.
- Our Counsel will host a third degree ceremony. September 8 was agreed upon as a possible date.
- With ending of the Council's Centennial as of June 2013, our Council needs to review its direction for the next 100 years.
- Committee will generate a scrap book on what represents the Council for the last 100 years.
- The recorder will be asked to summarize what our Council has done from July 2012 through June 2013. What work has our Council done in supporting the community through various charities?
- Council needs to establish a website. For doing this, our Council needs a volunteer to administer the site. This will require posting a link for the Council's calendar, link for monthly bulletin, costing the creation of the website, establishing a budget, and determining if the Council needs to outsource creation and maintenance of the website.
- Establish a program for our Council to connect with local parishes within the City of Santa Barbara.
- Establish a budget for doing special works at parishes in the City of Santa Barbara. Pastors could depend on the Knights for helping with special projects.
- Announced a District Deputy Meeting scheduled for July 16, 7:00 PM.
- Monthly social has been set for September 25. Knight's Nite Out has been set for October 23.

Under communication,

- Acting recorder read a letter from the Bluejacket Teenage Club requesting help of \$300 for liability insurance.
- Letter was received from Dr. Paul Harrington, thanking the Council for its generous contribution of \$16,000 to Bishop Garcia Diego High School.

Under the Treasurer's report, Brother Bruce Garcia reported a checkbook balance of \$1,964.37. Receiving no financial statement for June, there was no report on the Council's income and expenses.

The financial secretary reported five bills paid.

Brother Ray provided the Grand Knight and members with

a Centennial Report, income and expenses. Total expenses are \$3,353.39, total income \$4,418.00 with net to the Council of \$1,064.61.

Under new membership, Brother Ray provided a first reading for Alex Castellanos, and a second reading for Ricardo Lemos.

On the second reading of Ricardo Lemos, a motion was moved by Brother David Chavez and second by Brother Mark Wietstock to approve of Ricardo's nomination for membership. On call of the question, motion was approved.

Under Old Business:

- Brother Mark reviewed plans for Old Spanish Days Fiesta, July 30 through August 3, 11:00 AM to 10:00 PM.

Under New Business,

- A letter was received from Fr. Charles offering the Council the opportunity to celebrate Columbus Day by having the members of Council 1684 attend the 9:00 AM Mass on Sunday, October 13 at St. Barbara Church, Old Mission Santa Barbara. A motion was made by James Bauer and second by David Chavez to accept the offer.
- Brother Richard Rink suggested that the Council publish a special issue of the Council's bulletin celebrating the Council's Centennial. Brother Richard provided an outline of its content. Grand Knight stated that Brother Richard is approved to move ahead with the project.

There was no Field Agent's report.

Under the District Deputy's report, Brother Ray Centeno provided the following comments:

- Thanked Council 1684 for their enthusiasm as knights.
- Introduced Brother Bruce Garcia as Ray's new District Warden for our area.
- Provided the Grand Knight with a Grand Knight Planner.
- Announced special dates: Saturday, July 13 – installation of State Officers, Simi Valley; Tuesday, July 16 – District Deputy's Meeting, St. Joseph Parish in Carpinteria; Friday, July 26 – Chapter Officer's Installation, St. Joseph Parish in Carpinteria.
- Recognized the Council's successful newsletter, and Mark's hard work in using the Pepsi wagon during the Fiesta as a fund raiser.
- Applauded our Council's willingness to conduct second and third degree ceremonies.
- Stated the importance for councils filing their IRS 199 forms.
- Stated that communication is important as a foundation for any organization.
- He announced that he will be a regular attendee at our council meetings.

Pro-Life Report

Pope Francis gives pro-life / family / freedom marching orders to Knights

Our Order has received its orders! Pope Francis recently urged us to defend human life, marriage, normal sexuality, and the rights of believers.

Vatican Secretary of State Tarcisio Cardinal Bertone sent a letter expressing the Pope’s thoughts to our annual convention in San Antonio. “Conscious of the specific responsibility which the lay faithful have for the Church’s mission,” it says, “[Pope Francis] invites each Knight, and every Council, to bear witness to the authentic nature of marriage and the family, the sanctity and inviolable dignity of human life, and the beauty and truth of human sexuality.”

What’s more, the Pontiff appreciates “the clear public witness offered by the Knights of Columbus in protecting the right and duty of believers to participate responsibly, on the basis of their deepest convictions, in the life of society.” No doubt he was thinking of current grave attacks on Catholics’ religious freedom, such as Obama’s “HHS mandate” that will force Catholic (and other) hospitals, colleges and businesses to provide abortion-causing drugs to their workers or pay millions in fines.

Before he became Pope, he reminded society of its top priority by declaring, “The right to life is the first among human rights. To abort a child is to kill someone who cannot defend himself.” In 2012 he said, “Abortion is never a solution. We listen, support and [give] understanding from our place to save two lives: respect the human, being small and helpless, [then] they can take steps to preserve your life, allow birth, and then be creative in the search for ways to bring it to its full development.”

In 2007, as Cardinal Bergoglio, he noted with irony that “in Argentina we have the death penalty. A child conceived by the rape of a mentally ill or retarded woman can be condemned to death.” He joined all the bishops of Latin America in issuing the Aparecida Document, which declares, “people cannot receive Holy Communion and at the same time act or speak against the commandments, in particular when abortion, euthanasia, and other serious crimes against life and family are facilitated. This responsibility applies particularly to legislators, governors, and health professionals.”

Let each of us resolve to say *Yes!* to the Vicar of Christ by doing more to save the preborn babies, newborn babies, embryonic humans, and sick and elderly people whom our “post-Christian” society is killing. Let’s pray more and educate more. Let’s help moms to refuse abortions. Let’s vote 100 percent pro-life. And let’s join the too few Knights who take part in the Prayer Vigil to End Abortion at 3:00 p.m. (the hour of the Crucifixion) on the second Sunday of every month at “Planned Parenthood,” 518 Garden Street. Pope Francis would be delighted.

The minutes of the July meeting were accepted as read.

The Worthy Grand Knight reported on the following items:

- A Third Degree Exemplification will be held on Sunday, September 8 in the Serra Chapel Old Mission Santa Barbara with a pancake breakfast to follow.

WHY GO TO CHURCH

Someone wrote a letter to the editor of a newspaper and complained that it made no sense to go to church every Sunday. "I've gone for 30 years now," he wrote, "and in that time I have heard something like 3,000 sermons. But for the life of me, I can't remember a single one of them.

So, I think I'm wasting my time and the pastors are wasting theirs by giving sermons at all."

It went on for weeks until someone wrote this:

I've been married for 30 years now. In that time my wife has cooked some 30,000 meals. Last night, as always, she provided me with one of the best meals I've ever eaten. But for the life of me, I cannot recall the entire menu for a single one of those meals. But I do know this: They all nourished me and gave me the strength I needed to do my work. If my wife had not given me these meals, I would be physically dead today. Likewise,

if I had not gone to church for nourishment, I would be spiritually dead today."



La Cristiada: The Mexican People's War for Religious Liberty



The little-known 1920s persecution of Mexican Catholics that reached a fever pitch 87 years ago this month—and the civil war that followed – are the subjects of the newly-released book *La Cristiada: The Mexican People's War for Religious Liberty* by Jean Meyer, PhD (Square One Publishers: 2013).

Long-forgotten in the United States and little-known even in Mexico, the history of the Cristiada movement is well-documented and preserved within this book with an authoritative text amply illustrated by more than 300 photos and illustrations, many of which are from that forgotten time period.

The book follows the release of a major motion picture on the time period; “For Greater Glory,” starring Andy Garcia and Eva Longoria, was released in theaters last summer.

Popularly known as the “Cristero rebellion” or La Cristiada, the uprising and civil war that engulfed Mexico lasted for three years and reignited occasionally for decades thereafter. The situation escalated quickly in 1926, when in July of that year all Catholic religious services in the country were suspended.

The suspensions were in reaction to a severe government crackdown that curtailed the freedom of the Catholic Church, as well as that of members of the clergy and religious communities in Mexico. Public displays of religion were banned and foreign priests were expelled. Under Mexican President Plutarco Elías Calles, the government repression in the 1920s

turned increasingly vicious as many clergy and lay Mexican Catholics were summarily murdered for their faith.

In the United States, the increasingly brutal persecution of Catholics by the Mexican government was opposed by American Catholics and the Knights of Columbus. By contrast, it was endorsed by the then - powerful Ku Klux Klan.

The violent nature of the crackdown quickly resulted in a popular uprising chronicled in this new book, portions of which were first released by Meyer in Spanish.

Based in the United States but with members in Mexico since 1905, the Knights of Columbus worked hard to bring a peaceful end to the Mexican persecution in the 1920s by waging a public information campaign to inform Americans of the atrocities occurring just across the border. The organization also lobbied President Calvin Coolidge, seeking his help to end the violent persecution. Several members of the Knights of Columbus were martyred at the hands of the Mexican government, including six priests who were declared as saints by Blessed Pope John Paul II in 2000.

“While we in the United States are blessed to be in a country ruled by law where our differences are decided in courtrooms and voting booths, we should not forget that not all are so fortunate,” said Supreme Knight Carl Anderson. “It is heartening that this forgotten chapter in North American history is finally getting the attention it deserves.”

The Knights of Columbus commissioned the book’s English edition, and the supreme knight also penned its Foreword.
