Last Sunday (April 23), I had the great privilege of assisting with prayer of the Divine Mercy Chaplet, in song, at Our Lady of Sorrows Church. The event was very well-attended, by large numbers of people who have come to love this particular prayer/adoration, which came to us from the writings of St. Maria Faustina Kowalska ...a young, uneducated nun who lived in the convent of the Congregation of Sisters of Our Lady of Mercy in Poland during the 1930's. The tradition of veneration of the "Divine Mercy" portrait of Christ that St. Faustina saw in a vision, and later commissioned an artist to paint for her, is one that brings hope to the very hardest, lost and distant of all sinners. Deacon's Corner:

EASTER SUNDAY AND BEYOND

The fifty days from Easter to Pentecost are unlike other Liturgical Seasons, in that the Easter Season is to be celebrated as one feast day, a seven week long Sunday, it has often been called the "Great Sunday".

Easter is a season for rejoicing and celebrating in the new creation God has brought about in the resurrection of Christ. That doesn't mean we are supposed to pretend that there is no longer darkness and evil out there, waiting to tempt us. Easter is not about leaving suffering behind, but by finding hope and joy in the presence of Christ during our difficult times. Just as Easter does not fully consume evil, neither should evil consume Easter after the season. Every Sunday we are called to celebrate and relive the Easter miracle in the liturgy.

In 1998 Pope John Paul II wrote an apostolic letter, *Dies Domini*, on keeping the Lord's Day holy. He describes Sundays as not only *Dies Domini*, but also *Dies Christi*, Christ's Day, the day of new creation.

Although, for many it may be getting more difficult to attend Mass on Sundays, with busy work schedules and commitments; but we should remember it probably wasn't easy for the first century disciples to get together on the first day of the week to celebrate the resurrection either.

For over 2000 years we, Christians, have not forgotten the sacrifice Jesus made to save his Father's people, and only through our renewed and relived weekly and even daily celebrations will we be able to maintain our courage and strength to keep the light of the risen Christ in our lives during Easter and beyond.

General Meeting of Council 1684
Wednesday, April 12, 2017

Prior to the business meeting, the Officers Meeting was held at 6:45 pm followed at 7:40 pm with a Second Degree Ceremony. Seventeen members were present when on April 12 at 8:35 pm Grand Knight Mark Wietstock called the Council meeting to order. Upon closing the meeting doors, Acting Warden Ray Charpentier verified membership cards followed by the Grand Knight leading the members in the opening prayer and Pledge of Allegiance. On attendance of officers, ten were present.

On failure to have a quorum at the March meeting, no minutes were read.

Under Worthy Grand Knight's Report:

- On the Dissolution of the Home Association, Grand Knight and Dn. Nick Curran met Bill Yingst at Morgan Stanley. While at the present the Council holds two trusts, placing all accounts under a single Charitable Trust may not be workable for our Council in how it presently operates. More investigation needs on merging funds as well as question on tax implications.
- On the Essay Contest for grade school children, the submitted essays have been read and winners have been selected. Announcement of winners will be made at the Council's Social Dinner Wednesday, April 26. Only family members of first place winners are invited.
- Scholarship Dinner is being held Wednesday, May 24. Since our Council's income has increased for our Columbian Year 2016-2017, more funds are available for scholarships.
- Old Spanish Days Fiesta is scheduled for August 2 – 6. Our Council will again be selling soft drinks and bottled water at Mercado del Norte (Mackenzie Park) August 2 – 5. Volunteers are needed to staff the Pepsi Van.
- Our Council representatives for the State K of C Convention May 18-20 are Brothers Matthew Najera and Mark Wietstock.
- Installation of officers for Columbian Year 2017-2018 is scheduled for Saturday, June 24. Agenda: 9:00 am Installation Ceremony – no Mass, 10:00 am Pancake Breakfast. Location for installation ceremony and breakfast is Serra Hall.
- Third Degree Ceremony is scheduled at Lompoc, Saturday April 22. A First Degree Ceremony is scheduled at Serra Hall on Wednesday May 10.

Under Treasurer's Report:

- Income for March was \$2,426.08. After deposits of \$701.95 and withdrawals of \$2,286.42, ending March balance was \$841.61.

Following a closing prayer by Worthy Grand Knight, the Council meeting for April was adjourned at 8:58 pm.

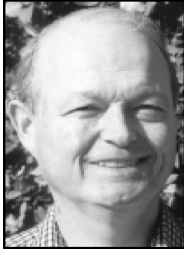

On Their 100th Anniversary, Mary's Fatima Messages Are Especially Crucial Because of Abortion, Other Sins

In the end, though, Mary promised that "my Immaculate Heart will triumph, the Holy Father will consecrate Russia to me, Russia will be converted, and a certain period of peace will be granted to the world."

What "errors" did Communist Russia "scatter" worldwide? She was the first country to legalize abortion, and now, after 100 years, abortionists have murdered literally BILLIONS of babies worldwide. The Communists also pioneered atheism (especially in the schools), immoral "sex education," easy divorce and radical feminism.

Even though Red Russia is no more, her errors have led countless people worldwide into grave sins. Who will make reparation for all these offenses? Who will help Mary prevent nuclear war? We Catholics must do it. We must make the five First Saturdays. Mary also said, "Say the Rosary every day to obtain peace for the world." Plus, she asked us to wear the Brown Scapular.

Field Agent's Message

THE PITFALLS OF REPLACING COVERAGE

You know the old saying, “the grass seems greener on the other side of the fence,” but we all know that it rarely is. The same holds true when it comes to replacing your existing Knights of Columbus life insurance with coverage offered by another company. Perceptions are deceiving. A move to the “greener” grass on the other side of the fence might seem like a good one, but it can leave you with less *green* in your wallet — in some cases, a lot less. That’s why it pays to remember another old adage, “Read the fine print.”

There are many reasons to keep your existing coverage in force, whether that coverage is with the Knights of Columbus or with another company. I’ll focus on

the potential pitfalls of replacing coverage here — pitfalls that an agent trying to convince you that the grass actually is greener might neglect to mention.

First, all life insurance contracts contain a *contestability period*, which allows the insurer to contest claims made for a period — typically two years — after the contract is issued. Chances are this is no longer an issue with your current coverage.

Second, it’s unlikely that you can obtain the same amount of coverage, for the same premium, that you were able to obtain with your existing contract. The two factors that determine how much you’ll need to pay for life insurance coverage are age and health. Certainly, you’re older now than you were when you took out your current coverage. There’s no way around that. And you have to ask yourself, has your health changed during that time? Is your blood pressure the same? Your cholesterol? Have you gained weight? All these factors can affect the amount of coverage you’ll get for your premium dollar.


If someone encourages you to replace — or worse, drop — your existing coverage, please call me. I’ll show you how your existing coverage is working for you and why replacement is rarely in your best interest.

Added comments from the State Council that I'm passing on:

- 1) Remember, one Admission Degree, Per Council, Per Month, even if it is only for one member. All members must participate in growing the Order by recruiting new members.

State Council and Supreme Council suggest Councils hold membership drives on the following dates:

August 6 and 7 (Quick Start Recruitment)

October 8 and 9 (Columbus Day)

Councils can hold recruitment drives at any time. Even at Council events such as Fish Fries or Pancake Breakfasts.

One on one recruitment is also suggested and is the most effective.

- 2) All Councils have the potential to achieve Star Council. There are now 120 days left to become a Star Council. Councils can review what programs held during the Columbian year qualify in the major service categories: Church, Community, Council, Culture of Life, Family and Youth.

After identifying these programs, submit Form #SP-7 (Columbian Service Award Application) to the Supreme Council Office. Remember to qualify for the Columbian Award, at least four of the programs must also be designated as Domestic Church activities.

- 3) The State Convention will be held in San Diego at the Town and Country Inn from May 18 -21. All Councils must send in their delegates names to the State.
- 4) All Councils should have ready an Officers' Slate to vote on for the next Columbian Year.

HISTORY OF THE KNIGHT'S OF COLUMBUS - THE FOUNDING: 1882-18

Late-19th century Connecticut was marked by the growing prevalence of fraternal benefit societies, hostility toward Catholic immigrants and dangerous working conditions in factories that left many families fatherless. Recognizing a vital, practical need in his community, Father Michael J. McGivney, the 29-year-old assistant pastor of St. Mary's Church in New Haven, Conn., gathered a group of men at his parish on Oct. 2, 1881. He proposed establishing a lay organization, the goal of which would be to prevent Catholic men from entering secret societies whose membership was antithetical to Church teaching, to unite men of Catholic faith and to provide for the families of deceased members.

As a symbol that allegiance to their country did not conflict with allegiance to their faith, the organization's members took as their patron Christopher Columbus — recognized as a Catholic and celebrated as the discoverer of America. Thanks to Father McGivney's persistence, the Knights of Columbus elected officers in February 1882 and officially assumed corporate status on March 29.



Wednesday Morning, Feb. 8, 1882.

The first meeting of those interested in the Catholic organization known as the Knights of Columbus was held in St. Mary's church Monday evening, and was presided over by James T. Mullen, T. J. Coffee acting as secretary. About sixty were present. A discussion occurred relative to the by-laws of the organization, and it was left to a committee of five to settle and report at the next meeting. Persons will be admitted to membership between eighteen and forty-five years. Another meeting takes place in two weeks.

The Feb 8, 1882 edition of the New Haven Morning Journal and Courier provides a short announcement for the first meeting of the Knights of Columbus.

In addition to the Order's stated benefits, Catholic men were drawn to the Knights because of its emphasis on serving one's Church, community and family with virtue. Writing in *The Columbiad* in 1898, a year before he was elected supreme knight, Edward L. Hearn wrote that a Knight should live according to the virtues of loyalty, charity, courtesy and modesty, as well as "self-denial and careful respect for the feelings of others." Fraternity and patriotism were added to the Knights' founding principles of charity and unity in 1885 and 1900, respectively.

- 1882: The Knights of Columbus is born on Feb. 6, 1882, when the first members choose Columbus as their patron. Immediately after the Order's March 29 incorporation, Father McGivney sends the first diocesan-wide appeal for new members to his fellow priests.
- 1886: By the end of his four-year tenure as supreme knight, James T. Mullen personally presides at the institution of 22 of the first 38 councils. John J. Phelan is elected to succeed him and is the first supreme knight to sense the Order's destiny as a national society.
- 1890: Father McGivney dies Aug. 14, 1890. His funeral Mass is celebrated in Thomaston, Conn., four days later.
- 1892: The Order passes laws allowing noninsurance or associate members to join.
- 1892: 6,000 Knights march in the New Haven Columbus Day parade to celebrate the 400th anniversary of Columbus' discovery of the New World.
- 1895: The Vatican's first acknowledgment of the Knights comes when Archbishop Francesco Satolli, apostolic delegate to the United States, writes a letter extolling the "merits of this splendid Catholic organization" and giving the Order his apostolic blessing.
- 1897: On Nov. 25, 1897, Canada's first council — Montreal Council 284 — is chartered.
