
**T**he Council did hold a Council meeting on April 8 using the internet and member's cell-phones along with a special APP (short for cellphone application) called Zoom.

## AGE DISCRIMINATION: IF YOU GET COVID-19, WILL THEY LET YOU DIE?

**O**ur Holy Catholic Faith teaches us that human life is sacred, from fertilization till natural death, and that all people have equal value, no matter how young or old. Our Declaration of Independence, too, proclaims the equality of all, and the 14<sup>th</sup> Amendment to the U.S. Constitution mandates “equal protection of the laws” to everyone. But as America grows more and more non-Christian, many decision-makers believe older people are disposable, like old dogs and cats.

News stories about the COVID-19 crisis have reported that some hospitals are simply refusing to treat people over 60 or 65 years old—a death sentence, in many cases. Some health officials, facing (or fearing) overwhelming numbers of patients, choose to devote their limited resources to saving younger patients.

But denying treatment to someone because of age violates the Age Discrimination Act of 1975. That law says no hospital that gets federal tax dollars “may...exclude, deny, or limit services to, or otherwise discriminate against, persons on the basis of age.”

Alexandra DeSanctis, writing in National Review Online (March 25, 2020), quotes Charles LiMandri, special counsel for the Freedom of Conscience Defense Fund and the Thomas More Society legal group, on age discrimination in healthcare.

Federal law requires that decisions regarding the critical care of patients during the current crisis not discriminate on the basis of disability or age. In this respect, anticipated longevity or quality of life are inappropriate issues for consideration. Decisions must be made solely on clinical factors as to which patients have the greatest need and the best prospect of a good medical outcome. Therefore, disability and age should not be used as categorical exclusions in making these critical decisions.

Two deadly viruses threaten us today: COVID-19 and a godless view of humanity that sees people merely as higher animals. Pope St. John Paul II admonished us that “Those who possess certain rights have a duty to defend them.” If you or a loved one ever face denial of medical treatment because of your age, contact a pro-life attorney group such as Life Legal Defense Foundation (707-224-6675 or [info@lldf.org](mailto:info@lldf.org)) for help.

## **Knights Sponsored Babe Ruth's Final Red Sox Game**



*K of C Council that Ruth was a member sponsored his last games as a Boston Red Sox player in Fenway Park*

**T**he Curse of the Bambino wasn't a reality yet in the minds of the 31,000 fans who crowded Fenway Park for a double-header on Sept. 20, 1919. They were there to see Babe Ruth pitch *and* hit for "Babe Ruth Day."

Although the Bostonians didn't realize it, the day would be the final time Ruth played a home-game at Fenway Park in a Red Sox uniform. And it was a game sponsored by the local Knights of Columbus.

Ruth became a Knight earlier that year, joining Pere Marquette Council 271 in South Boston. The council enthusiastically participated in baseball, even having their own competitive team — “the fastest baseball team representing the Order in Greater Boston.” And they wanted to honor their brother Knight, the game’s rising star.

According to the *Boston Daily Globe*, the council met on Sept. 9 to “perfect arrangements” for the occasion making “every effort” to get “every member interested in the testimonial to the king of sluggers.”

That year, Ruth was on his way to becoming the king of sluggers. By late September, he was on pace to tie the single-season home-run record, which then was 27, held by Chicago White Stockings’ Ned Williamson since 1884. But the sixth-placed Red Sox weren’t poised to repeat as World Series champions as they squared off against the first-placed, and now infamous, White Sox in the double-header.

In game one, Ruth started as pitcher, as he did 15 times that season. But during the game, he wasn’t electrifying, giving up three runs for a 3-3 tie going into the 9th inning. But when he approached the plate as a hitter in the bottom of the 9th, with the game on the line, Ruth did what he did best that season: he hit a home-run.

It was a solo, walk-off blast — the first of his career — that sent the ball “sailing over the scoreboard to the right of the clock and through a window of a building across Lansdowne St.” and tied the single-season home-run record.

Between game one and two, Pere Marquette Council’s Grand Knight Arthur Leary presented Ruth and his wife with \$600 in United States Treasury savings certificates. Both teams gathered alongside Ruth and his wife at home plate for the presentation.

Besides Ruth, other Knights present — including Red Sox second baseman Mike McNally along with Eddie Murphy, Shano Collins, Hall of Famer Red Faber and John Sullivan of the White Sox — were presented “fraternal charms.”

*(Side note: The White Sox mentioned were not implicated in the Black Sox Scandal — the fixing of the 1919 World Series)*

Game two was less dramatic than the first. Ruth went one-for-three, getting an RBI double as the Red Sox went on to beat the White Sox 5-4. A few days later, he would break the single-season home-run record, ending up with 29. The next season, Ruth swapped his Red Sox uniform for New York Yankee pinstripes, kicking off the 86-year “curse” that ended in 2004.

Ruth would remain a member of Pere Marquette Council even after going to the Bronx Bombers and remained active with Knights throughout his life, including through post-season barnstorming tours, until his death in 1948. Knights of Columbus councils throughout the country would sponsor other games with the league’s biggest stars to continue the growth of the sport.

## **More Than 2,000 Men Join K of C Amid Pandemic**

### **Men continually seek ways to step into the breach to assist brother, parish and community during the coronavirus pandemic**

**M**ore than 2,000 men joined the Knights of Columbus during the first ever online Exemplification of Charity, Unity and Fraternity held on April 16. The exemplification was hosted digitally by the Supreme Council as a unique opportunity for men to join the Order in a time of social distancing and minimizing mass gatherings. In his introductory remarks to the exemplification, Supreme Knight Carl Anderson emphasized that the Knights of Columbus' principles - charity, unity and fraternity - are "needed now more than ever."

The online event took just under 40 minutes and nearly every jurisdiction in the United States and Canada was represented. Pennsylvania, Michigan, Texas and California were among the jurisdictions with the highest new member totals.

"Catholic men in our state, even during these times, want to belong to an organization like the Knights of Columbus to help others," said William Chasse, the state deputy of Michigan, on the Order's opportunity to increase its charitable impact. "The more that join the more we can help." Pennsylvania State Deputy Mark Jago was pleased with the turnout, saying it's "not surprising that Catholic men want to join us in our mission to serve others, especially now." Riley Quinlan was one of those men, joining the Knights during the first ever online exemplification.

"I was interested in joining the Knights to get involved with a specific church community, joined by like-minded Catholic men of faith," Quinlan said. "I wanted to connect with God through a community I can routinely serve. I am interested in helping out where I can during the challenges presented by COVID-19."

In addition to new men joining, more than 7,000 first and second degree members were able to obtain their third degree, and thousands more Knights and family members were able to observe and support the candidates. The new, public exemplification debuted earlier this year, with the first taking place at St. Mary's Church in New Haven, Conn., where the Order was founded.

This historic online event was organized by the Knights of Columbus's newly formed Fraternal Excellence Department lead by Retired Navy Captain Tom McCaffrey.

The Knights of Columbus is also adapting its charitable outreach during the COVID-19 pandemic, launching the new program "Leave No Neighbor Behind." The program encourages Knights to lead their families, protect their parishes and serve their communities through a variety of charitable initiatives that also keeps members safe.

Members of the Order have access to state of the art insurance and investments benefits, as well as the opportunity to put their faith in action in order to leave no neighbor behind in a strong, Catholic fraternal setting.
