Sisters of St. Joseph of Carondelet



Our Coat of Arms

The Sisters of St. Joseph of Carondelet sprang from the Congregation of the Sisters of St. Joseph founded in France in 1650, by the Jesuit Jean-Paul Medaille. The order was one of the first non-cloistered orders of women and they supported themselves by making lace. He based the constitution of the order on the rules of St. Ignatius and made the bishop of the diocese in which they served the superior. Hence the order was very adaptable to the local needs and spread rapidly in France mostly engaged in the care of orphanages and schools. In 1793 the convents and chapels of the sisters were confiscated and the religious were obliged to join communities in other countries or to return to their respective homes in the world. The congregation had a number of martyrs during the French Reign of Terror. Mother St. John Fontbonne, a heroic woman who narrowly escaped the guillotine, refounded the Sisters of St. Joseph at Lyon, France in 1807. The order recovered rapidly after their restoration.

In the year 1834 the diocese of St. Louis, Missouri asked for a colony of Sisters to come to America. Financial aid was obtained through the Countess de la Roche Jacquelin and in 1836, six sisters sailed from Havre and, after a perilous voyage of forty-nine days, reached New Orleans. Their new home, the mother-house of the future congregation of the Sisters of St. Joseph of Carondelet, was a humble log cabin located at Carondelet, a small town six miles south of St. Louis. Two of the sisters began St. Joseph Institute for the Deaf in 1837. This ministry continues to the present time. Because of the rapid growth of the order and the increasing demand for sisters from all parts of the United States, the community needed a way to give stability and uniformity to the growing congregation. In 1877, constitution of the Sisters of St. Joseph of Carondelet was issued so that communities of Sisters of St. Joseph in various dioceses were unified with the mother-house at Carondelet. They have been engaged in all kinds of service: parish schools, high schools, colleges, orphanages, schools for the deaf-mute and blind, hospitals-especially in the Civil War, schools for Indians and Black people, and houses for retreats. Houses have established through out the USA and in Japan, Chile and Peru. At the present time there are twenty-two other congregations of Sisters of St. Joseph joined with the 1800 Sisters of St. Joseph of Carondelet in a United States Federation of the Sisters of St. Joseph, representing about 7,000 sisters.

The order has had a presence in Santa Barbara for about 25 years and in Oxnard for about 100 years. At present there are 3 sisters of the order in Santa Barbara County, one serving as the administrator of the parish in New Cuyama and the others in Santa Barbara working with young adults in spiritual development and with children at Mt. Carmel parish in religious education. They are currently the largest group of religious women in the archdiocese. The sisters of St. Joseph of Carondelet founded such local institutions as St. Mary's College, Daniel Freeman Hospital and Marina Hospital. Their website is www.csjcarondelet.org.







- 3) The bus trip to Our Lady of Angels is still in the planning stages. I hope to start work on it shortly as time permits (I'm a tax accountant).



***Other Faiths Believe Abortion
is Not An Option***

This month's article on pro-life is a set of excerpts from a longer article found on the internet at www.newscientist.com. This site usually contains articles on the latest findings in the scientific community but this article describes a unique happening. It is the story of an orthodox Jewish Rabbi, Josef Ekstein, and his work in solving the problem of the genetic disease known as Tay-Sachs.

Here are some excerpts "For rabbi Josef Ekstein, an orthodox Jew living in Brooklyn, this was personal: he was forced to watch helplessly as four of his children fell prey to an inherited disease. Weren't there tests for Tay-Sachs? A test was developed in the 1970s. But it was not used by the orthodox Jewish community because abortion is forbidden, so prenatal screening was out of the question.... I knew there was a way around his problem and that the transmission of Tay-Sachs was preventable. But first I had to get our community to admit the existence of genetic diseases. Because of the stigma, everyone was in denial. Why was that? A disease that runs in the family was a very taboo subject in our community. Families who had children with diseases felt stigmatized and didn't talk about it for fear that their healthy children would not be able to marry. I know of two brothers who had children with Tay-Sachs, but neither told the other. I heard of a doctor and his wife who had a Tay-Sachs child and would hardly ever go out. There was only one person they trusted with their secret, so he was the only the person who could babysit. Many ill children were sent away to care homes. I did his myself. I was one of those people who had tried to deny the problem.... Did you have a plan? At first I wanted to encourage conventional testing, but rabbis and community leaders were skeptical. They feared that if we identified carriers we would do more harm than good, so we developed an alternative, confidential testing method. I had to learn about genetics the hard way, by teaching myself. It was difficult, but if there is a will, there is a way. How does your system work? We call our screening system Dor Yeshorim, and it is based on the genetic compatibility of couples. DNA from both partners is screened for genes that can cause serious recessive diseases. On average, 1 in 4 children born to a couple with the same recessive gene will have such a disease. Before a couple decide to get engaged we can tell them if they are genetically compatible - whether or not they carry a mutation for the same disease. Unfortunately our system can only deal with recessive diseases. There are many more ethical and practical questions with dominant traits. We test young people in schools and colleges, long before they consider serious relationships. The screening is carried out by accredited laboratories, and we insist on confidentiality.



Other Faiths Believe Abortion is Not An Option

At the time of the test, every person is given a coded number, and Dor Yeshorim keeps a record of this number, the participant's date of birth, and telephone number. We do not ask for the person's name and the results are not revealed at this time. Before two people become serious about each other, they contact Dor Yeshorim with both code numbers, their phone number and dates of birth and we inform them whether they are compatible or not. Even if one person in the couple is a carrier, the pair are still compatible and so we do not reveal that one of them has the gene. Incompatible couples are informed of their risks and are given as much counseling as they need to deal with the implications. Why don't you give individuals the full information? What about the right to know? People also have the right not to know, and using the Dor Yeshorim system means they have opted not to know. So we do not reveal the status of an individual. After all, if a person is a carrier, it has no bearing on their health and it never will. Research shows that this knowledge has a negative emotional impact on young people. Has Dor Yeshorim worked? Yes. We have the joy of seeing it succeed. Today, Tay-Sachs is almost nonexistent in New York's orthodox community, and in Israel too. In the 1970s, the 16-bed Tay-Sachs ward in New York's Kingsbrook Jewish Medical Center was filled to capacity. Since 1996, the ward has had no Tay-Sachs patients. "To me it is a blessing to know that other religions believe that abortion is wrong and that others are doing things to deal with it. This is just one of them.
