A Great Example of a Charity

One of the finest local charities that I can think of is Catholic Charities of Santa Barbara County. For almost 100 years this organization has provided direct assistance to those in need. It is part of a nation-wide network of over 1,600 local organizations that have been helping the poor in America since colonial times. Despite its name, Catholic Charities receives no funding from the Archdiocese, and they serve the needy regardless of their faith.

As you probably know, we have in our council a knight who is a tireless volunteer for Catholic Charities. In the latest issue of their bulletin, Fritz Cahill was singled out and honored for his work. Quoting from *The Catalyst*,

“Since 1981, he has tirelessly – and quietly – been contributing his time, energy, smile, car and other resources to help us in our Santa Barbara facility. Through the extraordinary generosity of St. Raphael’s Parish and the Knights of Columbus, Fritz delivers food and staples daily to the Catholic Charities food pantry on Haley Street. There have often been days when the only food in the pantry is that which Fritz delivers from St. Raphael’s parishioners.”

Any of us who have ever worked at one of our fish fries or other dinners knows that no extra food ever goes to waste. One call to Fritz



Thanksgiving Day , legal holiday in the U.S., first celebrated in early colonial times in New England. The actual origin, however, is probably the harvest festivals that are traditional in many parts of the world Festivals and Feasts. After the first harvest was completed by the Plymouth colonists in 1621, Governor William Bradford proclaimed a day of thanksgiving and prayer, shared by all the colonists and neighboring Native Americans. The Pilgrims of Plymouth Rock held their Thanksgiving in 1621 as a three day "thank you" celebration to the leaders of the Wampanoag Indian tribe and their families for teaching them the survival skills they needed to make it in the New World. It was their good fortune that the tradition of the Wampanoag's was to treat any visitor to their homes with a share of whatever food the family had, even if supplies were low It was also an amazing act of providence that one of the Wampanoag, Tisquantum or Squanto, had become close friends with a British explorer, John Weymouth, and had learned the Pilgrim's language in his travels to England with Weymouth. After the first New England Thanksgiving the custom spread throughout the colonies, but each region chose its own date.



Thanksgiving Day!

In 1789 George Washington, the first president of the United States proclaimed November 26 a day of Thanksgiving. Thanksgiving day continued to be celebrated in the United States on different days in different states until Mrs. Sarah Josepha Hale, editor of Godey's Lady's Book, decided to do something about it. For more than 30 years she wrote letters to the governors and presidents asking them to make Thanksgiving Day a national holiday. Finally, in 1863, President Lincoln issued a White House proclamation calling on the "whole American people" wherever they lived to unite "with one heart and one voice" in observing a special day of thanksgiving. Setting apart the last Thursday of November for the purpose, the President urged prayers in the churches and in the homes to "implore the interposition of the almighty God to heal the wounds of the nations and to restore it...to full enjoyment of peace, harmony, tranquility and union." He also states that they express heartfelt thanks for the "blessing of fruitful fields and healthful skies."

PROTOCOL III



PROTOCOL III: This is the third and last of the articles on Protocol. Here are a few issues not requiring any lengthy explanation. That does not make them any less important! The Grand Knight should address all members who are not officers as “Brother”. All officers should be addressed by their proper title, e.g. Worthy Chancellor, Worthy Financial Secretary, etc.

When the District Deputy attends a meeting at his own Council he need not be specifically recognized unless he has been invited or requests to be so recognized. This will allow him to engage in the regular business of his home council without involving the position he holds. The District Deputy should notify the Grand Knight of a Council in writing and in advance (one week to ten days) when making an official visit so that all officers will be present with their books and records.

The Grand Knight, in keeping with the dignity of his office, should be neatly and properly dressed. He should request his officers do likewise. Thus he will have set the proper dress code for the membership to follow. (Members are not expected to wear jackets and ties to all meetings but they should be neatly dressed in clean clothes and wearing shoes).

Our Nation’s flag may be displayed flat, above and behind the speaker. When the flag is displayed horizontally or vertically against a wall, the stars should always be at the observer’s left. If the flag is on a staff it should always be at the right side of the speaker as he faces the audience.

All officers should wear their current jewel of office at all council meetings. At council functions and socials, it is proper and fitting that grand knights, district deputies, etc. wear their jewel of office.

I am not addressing the protocol involved in correspondence or invitations to and the seating arrangements for dignitaries or social functions. These are addressed at length in the PROTOCOL handbook published by the Knights of Columbus. The Grand Knight and the Advocate should always have a copy at hand. When you are involved in inviting guests to a social function or planning their seating arrangements, this handbook is absolutely necessary.

It is impossible to cite a rule for every situation. Under difficult circumstances not specifically covered by the handbook simply use good judgment and apply common courtesy. Mark Twain summed up the situation when he said, “Always do right. You will please some people and astonish the rest.”

Current Activities


There were a few noteworthy activities that took place between October 1st & 31st 2004:

Sam promised that Brother Terry Sliger would cook his special sauce, there would be an accordion player and that there would be sing-along. Let's hope that many of you Knights were able to go and enjoy the evening.
- 4) October 24, 2004 - The annual Knights Tootsie Roll Drive will be held after all the Masses and at the pancake breakfast. A number of Knights have already signed up to help out. We will be having a donation canister in the hall as well. Sadly, due to the flu shot vaccine shortage, the flu shot clinic promised for October 24 was cancelled.





