Peace! Fr. Paul Rospond, C.S.P. Dear Brother Knights,

We all know that Christmas is about Jesus: His birth, His presence among us, and the reason He came into the world. And we all know that "the reason for the season" so easily gets lost amid shopping, winter holiday songs and our lists of things to do.

So, what CAN we do to "Keep Christ in Christmas?" Here's a few suggestions. Maybe you all have more ideas.

1) Observe Advent. Take some prayer time. Give an Advent Galendar to a youngster in the family. Keep an Advent wreath in the house and light the candles at your family meal. Here at St. Mark's we distribute daily devotionals for Advent; something like that might help you keep Advent in prayer.

2) Prepare your heart. Making a confession or taking part in a Penance

Service may be your way to do this. Taking quiet time to read the Advent Scriptures might be another way.

3) Invite people into the mystery we celebrate. This can be as simple as explaining to a child the meaning of the Christmas crèche in your home. Last year I gave (an unbreakable) Christmas set to twin god-daughters, age 4. They loved the figures and the story so much that they took the lambs to bed with them.

4) Be a spiritual leader for your family. E.g. initiate a grace before the family digs in to he Christmas feast.

5) "Come Home for Christmas" We all have "wandered away Catholics" among our friends & family. Invite them gently. Our invitation is important, but let the Holy Spirit do the real work. People come back to the Church when they are ready. Our job is to give our own witness as Christians and be ready to welcome them back when they are ready to return.

6) Remember our call to Charity.
