

The Right to Buy

The laws and rules of our Order, as well as state laws, specify that the Knights of Columbus may accept insurance applications from members only. As a member, you may apply for insurance on yourself, your wife and your minor children.

The Order's Board of Directors has taken action, though, to assure that a Knight's widow maintains the right to purchase additional insurance for a limited time. This can be of great benefit and comfort to those we leave behind.

This "right to apply" is available only to the widows of insured members. If a member has not availed himself of our highly rated life insurance program, or purchased an annuity or long-term care policy, this benefit is not available to his widow.

But if the member was an insured member, his widow has the right to apply for additional insurance on her life and on the life of the member's minor children. This right must be exercised within one year following the Order's receipt of proof of the insured's death.

Know two things. First, I'll assist your widow and children in any way possible if you should die, both with your Knights of Columbus insurance and any other life insurance you may have. Second, I'll provide them my best professional advice and service, to assure that they have adequate insurance protection.

I have no greater responsibility.

Should pandemic vaccine skip kids, elderly?

Two U.S. bioethicists have proposed withholding a flu vaccine from young children and the elderly in the event of a pandemic.

They argue people between early adolescence and middle age should be given priority over babies, toddlers and those 65 and older, which is exactly the opposite of what Canada's pandemic plan proposes.

Writing today in the journal *Science*, Ezekiel Emanuel and Alan Wertheimer argue the "save the most lives" principle driving U.S. and Canadian flu planning -- which gives priority to those at highest risk of being hospitalized or dying -- needs to be rethought. That approach puts the sick and elderly ahead of the healthy.

Instead, the bioethicists suggest scarce shots should be given based on "the amount the person has invested in his or her life balanced by the amount left to live."

It's called the "life-cycle" principle, whereby each person should be able to live through the full cycle of life -- "to be young, then get a career, a family and then grow old," said Mr. Emanuel, who with Mr. Wertheimer is from the clinical bioethics department at the National Institutes of Health in Bethesda, Md., said in an interview.

Under that framework, 20-year-olds would be valued more than one-year-old babies.

"The one-year-old, we have not invested as much, they're not on the brink of leading their own lives."

People between ages 13 and 40 would come after health-care workers and people who make and distribute vaccines.

Under the life-cycle principle, people over 65 with two or more "high-risk" conditions -- such as chronic respiratory disease or heart or kidney disease -- would be at the bottom of the list for a vaccine.

"Death seems more tragic when a child or young adult dies than an elderly person -- not because the lives of older people are less valuable, but because the younger person has not had the opportunity to live and develop through all stages of life. Although the life-cycle principle favors some ages, it is also intrinsically egalitarian," the report says.

Under Canada's flu pandemic preparedness plan, healthy teenagers and adults are at the very bottom, after mortuary workers.

"The potential threat of pandemic influenza is staggering," the team reports in *Science*. The United States alone would see "1.9 million deaths, 90 million people sick and nearly 10 million people hospi-

talized, with almost 1.5 million requiring intensive care units."

But because it would take four months minimum from the identification of a pandemic strain until the first vaccine could be produced, hard choices will have to be made about who gets the vaccine first.

The Science report looks at different principles for how to value each human life. Do we save the most fragile? Those with the most years left? Those who respond best to scarce drugs? Those "instrumental in making society flourish?" Or people to bury the dead?

According to Mr. Emanuel, vaccine production workers and frontline health workers should be the first two groups in line.

"Why? Because they're saving other people's lives."

"After the first two, who would you give priority to?" Mr. Emanuel said.

"The 'save the most lives' principle that is being used in Canada and recommended to the U.S. government says you then save people who are over 65 and have conditions that make them susceptible to flu," Mr. Emanuel said.

"Our principle says you save young people, 20 to 40."

To maintain public order, priority within that group would go to police officers, firefighters, grocery delivery clerks, telecommunications people, and other essential service workers.

Under Canada's flu plan, people at high risk of developing severe or fatal complications to the flu, including about one million people aged 65 and older, would come after health care and essential service workers.

Healthy adults (about 8.7 million people) and children aged two to 18, who are considered at the lowest risk of developing serious flu complications, rank fourth and fifth, respectively, out of the five priority groups for vaccines. Deciding whether to vaccinate them will depend on having an adequate supply of vaccine, the flu plan says.

Dr. Arlene King, director general for pandemic preparedness at the Public Health Agency of Canada, said priority groups could be altered, depending on what the pandemic looks like when it occurs. For now, the list is based on the best expert assessment "of how we believe the pandemic will roll out in terms of greatest illness and deaths."

PRIORITIES FOR USE OF PANDEMIC VACCINE

PUBLIC HEALTH AGENCY OF CANADA

- 1) Health care workers, paramedics, public health workers.
- 2) Essential service providers (e.g. police, fire, army, utility workers, mortuary personnel).
- 3) Persons at high-risk of fatal outcomes (e.g. persons over 65, pregnant women, children 6-23 months, people in nursing homes).
- 4) Healthy adults.
- 5) Children 24 months to 18 years.

BIO-ETHICISTS PROPOSED 'LIFE-CYCLE PRINCIPLE PLAN'

- 1) Vaccine production and distribution workers.
- 2) Frontline health workers.
- 3) People 13 to 40 years with less than two high-risk conditions* (priority to key government leaders, public health officials, military, police, fire, utility and transport workers, funeral directors).
- 4) People 7 to 12 and 41 to 50 with less than two high-risk conditions.
- 5) People 6 months to 6 years and 51 to 64 with less than two high-risk conditions.
- 6) People over 65 with less than two high-risk conditions.
- 7) People 6 months to 64 years old with more than two high-risk conditions

*High-risk conditions include chronic respiratory disease, heart or kidney disease, diabetes or a depressed immune system because of cancer, HIV infection or some other cause.

Area USPS Letter Carriers Results in Gigantic
Collection of 4,000 Bags of Non-Perishable Food
Items With Catholic Charities of Santa Barbara**

The "Stamp Out Hunger Food Drive" sponsored by 75 United States Postal Service Letter Carriers from the 93117, 93110 and 93111 zip code areas collected an estimated 4,000 bags of non-perishable food items like canned meats and fish, canned soup, juice, pasta, vegetables, cereal and rice on Saturday, May 13 to help families in need in our community.

For each food drive, the letter carriers vote on the charity to receive the collection. This year, the carriers decided to give to Catholic Charities. With such an incredible contribution by the residents in the Goleta 93117 and Santa Barbara 93110 and 93111 area codes, Carolyn Pace, Customer Service Manager at the USPS site on 130 S. Patterson called Catholic Charities inquiring if they would coordinate the pickup of this tremendous amount of food items. Goleta resident Mike Murphy, the President of the Catholic Charities' Board of Advisors, was contacted and he and his helpers promised to be at the post office promptly to pick up the large amount of bags full of groceries.

Murphy, Fritz Cahill, Mrs. Pace, Frank Bognar, and others involved in food collections stated that this was the most ever collected in one day. "We appreciate very deeply the generosity of the residents for their tremendous contributions, the commitment of the 75 letter carriers and all the work by volunteers who transferred the gigantic food collections from the Post Office to St. Raphael's Parish Hall on Saturday from 2:30 to 6 p.m. and on Monday loading the two large trucks on three occasions to bring the

food items to Catholic Charities in Santa Barbara," stated Bognar, who is in his third year as Regional Director of Catholic Charities for Santa Barbara County.

Volunteers assisting with the Saturday work in transferring the food from the Postal Facility on Patterson Avenue to the St. Raphael Parish Hall included Fritz Cahill and his sons Tom and Steve, Mike Murphy and two of his daughters, Meghan and Colleen, John Meagher, Stephen Schlesselmann, Ken Mlodzik, Dorothy Gonzalez, Kerri McCarthy, and Wade Brown, a Boy Scout.

On Monday morning, Catholic Charities came with three men and two large trucks to pick up the huge amount of food. Lorenzo Martinez, Tony Fernandez and Bill Ruggiero of Catholic Charities could not believe what they saw in the Parish Hall, which was nearly half full of groceries. Assisting them in loading the large 14 foot boxed truck and large pickup were Luis Nungaray and Joe T. Kovach, parishioners. It took three trips to Catholic Charities to deliver the hundreds of bags of food items.

Cahill said he was appreciative of Dennis Franks from Toyota of Santa Barbara for the use of a large truck on Saturday afternoon in hauling the food from the USPO to St. Raphael's. He also commended everyone at the USPS for their overwhelming support in this extraordinary "Stamp Out Hunger Food Drive." The USPS supplied the postal boxes and carts to make the transfer of bags of food items much easier. Cahill's concluding statement, "All this food really shows the generosity of our community for this most worthy Food Drive. As in all things many people working together can do many extraordinary things for the less fortunate."

I hope that everything is in good repair so he can have a smooth, running start on his new assignment.

This past month of May, Brother Steve Schlesselmann and I attended the Knights of Columbus California State Council meeting in San Jose, CA as the voting delegates for Council 5300. The State Council meeting is actually pretty impressive; there were over 500 Councils represented. The meeting

took place in the San Jose Double Tree Hotel and utilized a quadruple wide ballroom to accommodate the formal meeting sessions. The sheer numbers of delegates is impressive, especially when you realize that these men represent Councils of all sizes from 30 members to two or three times our own Council's roster of 200.

The State Council meeting agenda and minutes were by-and-large predictable. A number of congratulatory resolutions were passed. The per capita tax will be increased by \$0.54/capita, primarily to cover travel expenses for State officers. A resolution to provide written recognition to every member of the US armed services was defeated after it was pointed out that the cost would exceed several million dollars. Several resolutions that dealt with controversial, "hot button" issues such as having the State Council affirm a position against the death penalty were discussed and later procedurally tabled to end the un-resolvable debates that ensued. A proposal to have the State Council provide insurance to all local Councils at an increased per capita tax of \$2.00/capita was defeated when several Councils mentioned that they had already found alternate insurance at lower rates.

As the Grand Knight delegate, I submitted the "365 Club" donation to Columbian Charities. Council 5300's donation was \$1,471.95 and was the fourth largest donation of all the contributing councils. On the other hand, we did not even make the radar for the top 50 MR Drive donations (Tootsie Roll drive). The lowest amount recognized was \$4,000+ and the top Council collected \$41,000+. But, I am very pleased that Brother Dan Knauss got Council 5300's MR Drive restarted this year and we were able to contribute \$949.48 to Special Olympics of Santa Barbara. Our Council has received several thank you notes from Ms. Ada Conner, Director of Special Olympics of Santa Barbara.

The month of May included a 3rd Degree ceremony for two of our Brother Knights. Congratulations to them both. We handed out orchids to all mothers on Mother's Day at all the Masses at St. Raphael's Church. There was a pancake breakfast on the Memorial Day weekend and, of course, we had our traditional Memorial Day Picnic in Stow Grove

Park.

This month of June please note that there will not be a blood drive with the pancake breakfast. The next blood drive will be Sunday August 12, coincident with the pancake breakfast.

Again, I want to thank all of you for the privilege and honor of serving as the Grand Knight for this past year. Please give your support to our next Grand Knight, Steve Schlesselmann, when he takes over for Columbian Year 2006—2007. Also, please come to the invocation for the new officers. I'll be there.




