**Prop 85 backers prepare for busy Respect Life Month**

Efforts to pass Proposition 85, the parental notification initiative on the upcoming state ballot, will dominate October's annual "Respect Life" events this year as parishioners and interfaith coalition members collaborate to increase voter support and turnout throughout the state Nov. 7.

Similar to last year's Prop 73, defeated by a 47 percent to 52 percent margin, Prop 85 proposes to amend the California Constitution to forbid physicians from performing abortions on underage girls until written notice has been delivered to parents/legal guardians and a minimum waiting period of 48 hours has taken place.

On Oct. 1, Cardinal Roger Mahony will address parishioners at Sunday Mass in a recorded message urging them to "support, work for and vote Yes on Proposition 85." As the cardinal explains in his message, "Parents are the best ones to help a minor daughter understand all her options if she becomes pregnant. Without parental involvement, other influences can dominate. Parental notification laws are desperately needed to protect young girls."

As with Prop 73, supporters are relying on a grass roots campaign of education and voter registration. "The Proposition 85 campaign has been a huge catalyst for our Hispanic Respect Life Committee Project," said Hispanics for Life spokesperson Astrid Bennett Gutierrez.

The Hispanic pro-life group, part of the archdiocesan Committee for Catholic Life Issues, will hold PNI evening workshops in English and Spanish for parish leaders at its recently-opened Prop 85 headquarters based at Los Angeles Pregnancy Services on 2524 West Seventh St. in downtown L.A. Free Spanish-language PNI materials, including brochures, bumper stickers and yard signs, are avail-

able at the crisis pregnancy center Monday through Saturday.

Many parish Respect Life leaders have downloaded English- and Spanish-language Prop 85 flyers and bulletin inserts from the bishops' California Catholic Conference website, [www.cacatholic.org](http://www.cacatholic.org). Since summer, the CCC has hosted several Prop 85 conference calls with parish pro-life leaders and Knights of Columbus members in efforts to promote passage of the PNI initiative.

"We are making an even greater effort to work collaboratively with the Knights of Columbus," said Marie Widmann, pro-life Catholic Ministries director for the San Bernardino Diocese. "Exchanging information with the Knights' leadership is a real positive thing that I hope will continue."

"Catholics for 85," a coalition of Catholic organizations supporting Prop 85, is calling for Catholic parishes and groups to publicly endorse the initiative on its website, [www.Catholicsfor85.org](http://www.Catholicsfor85.org). According to organizer Bill May, chairman and founder of the Bay Area-based non-profit, Catholics for the Common Good, the purpose of the coalition is to organize Catholics statewide and help them understand the parental notification law.

"Research shows that parental notification laws in other states reduce the number of abortions among teenagers and reduces sexual activity among them as well," asserted May. It is critical to pass Prop 85 to protect the health and welfare of girls and to assure that parents can exercise their responsibility for the physical and spiritual health of their children."

"Many voted against Prop 73 by mistake," he added, maintaining that PNI opponents "try to confuse voters as much as they can," with misleading information and rhetoric that infers religious groups may not endorse propositions.

"All non-profit organizations have the right to engage in issue advocacy so long as it does not constitute a substantial portion of their overall activities," explained James Sweeney, a lawyer who represents a number of non-profit clients including the CCC. "It's candidate advocacy that's absolutely prohibited."

### 38 YEARS SERVING THE KNIGHTS RALPH J. WENGLER'S INCREDIBLE SERVICE OVER THE YEARS INCLUDES 14 OFFICES HELD

One of the busiest Knights of Columbus members of Council 5300 is Ralph Joseph Wengler, an Honorary Life Member of Council 5300 who has held 14 KC offices during his 38-years as a Knight. Performing these incredible services continues to this day as he is in his 16<sup>th</sup> year as the Financial Secretary.

Born on October 25, 1930 to Joseph and Mary Hufnagel Wengler, Ralph and his two brothers, Norbert (Farmingdale, N.Y.), Joseph (Ronkoncoma, N.Y.)

and sister Marilyn Roche (Garden City, N.Y.) grew up attending Holy Child of Jesus Parish, and graduating there. His high school days were at Richmond Hill in Queens, N.Y., and in 1952 he earned a BA in Physics at Adelphi University.

Ralph married Catherine L. Salamone on July 21, 1956 at St. Matthews Church in Brooklyn with Father Nicholas Cesaro (Cathy's first cousin) performing the ceremony. They are the proud parents of four children: Alice Duckett (Orcutt), Andrew (Solvang), Theresa Lawson (Oxnard Keys), and Joseph (Rocklin, Ca.).

The Wenglers also cherish their five grandchildren and four great-grandchildren. These include Christine Wengler 20, David Duckett 28, Andrea Duckett Burns 26, Michelle Wengler 11, Emily Wengler 8. The four great-grandchildren are Arianna Duckett 6, Savannah Duckett 3, Daisy Burns 7 and Lily Burns 5.

Before coming to Goleta, Ralph and Cathy resided in Norwalk, CT, and Long Island where he was a member of the Volunteer Fire Department in Melville, L.I.

Before their marriage, Ralph served in the U.S. Army in 1952-54. His professional career included working for Servo Corp of America (1952-1961), Barnes Engineering (1961-1967) and Santa Barbara Research Center (1967-1989). He retired in 1989.

Ralph who was the Grand Knight of 1976-77 joined the Knights on September 25, 1968 with John Moynihan his sponsor. While serving as the 15<sup>th</sup> GK, the native of Brooklyn, N.Y. recalls a few of the goals he has achieved and for which he is proud: replacing the Cross on the lawn in front of the Santa Barbara Old Mission, bringing back nine hard earned trophies from the state convention and becoming a guest at the Supreme Convention after Brother Knight Joe Meitz won the state and national award for participation in Special Olympics. Ralph also cherishes his fond memories of Walt Merrigan, our Council founder in 1961.

Ralph has held the following offices during his 38-years as a Knight: Treasurer, Chancellor, Deputy Grand Knight, Grand Knight, District Deputy, Chapter Secretary, Chapter Treasurer, Chapter

Vice-President, Chapter President, Faithful Purser, Faithful Pilot, Faithful Navigator, Faithful Admiral and currently Financial Secretary.

Special highlights during his 38 years as a Knight include: attending Supreme Conventions in Indianapolis, Denver, New York City and the opening Mass in Washington D.C. His most memorable experience as a Knight to date was receiving a rosary from the late Past State Deputy Fred Pelletier after his return from a trip to the Vatican.

Ralph's recommendation to other Knights is to get involved in some manner regardless of their ages. There are so many activities that Knights of any age can participate in, especially attending business meetings. Joe Bauer, although he spends many hours working in Scouts, finds time to work many of the Knight's events.

A member of St. Raphael's Parish for 39 years, Ralph cited the MR Drive as his current favorite Knights' project. Over the years he also noted that the Special Olympics was tops.

A personal highlight of St. Raphael's Church was receiving a special gift from Pastor Stephen Noel Downes for deferring preparation work in the Hall Kitchen to late evening so that there would be no interference with another event. The gift was a biscuit joiner (woodworking tool).

Ralph sponsored Msgr. Henry Van Son and Msgr. Downes as two very special priests. Ralph pointed out, "Both were involved in actively working to better the Parish. Father Steve was reluctant to join the KC's but eventually conceded. Once he was a member, he was an enthusiastic member. He deserved the \$100,000 pledge from the Knights for the St. Raphael Community Center."

Ralph has been very involved in other parish organizations also. He has helped at Parish Picnics, Parish Festivals, Parish Council, Sociable Seniors, and the Bereavement Committee. Whenever a cook was needed Ralph would be there to assist in the meal.

"I learned to cook by becoming Culinary Arts Director and sticking with it for 23 years." He added, "Along with Roy Schrader's help, all KC events were taken in stride. I like most foods and skirt

steak is my current favorite.”

His community involvements centered on the Grand Jury, the Stow House, United Way and Walk to Emmaus.

Cathy was a school nurse, working in most of the Goleta schools at one time or another. She has been involved at Stow House since it opened in 1967. Her mother, Sabina Salamone, lived with them for 38 years until 2004 when the 101-year old moved into Santa Barbara Convalescent Hospital. *(editor's note: Sabina Salamone passed away on September 30<sup>th</sup>. The following note was received from Cathy: "My mom died this morning (Saturday, September 30); praise God, she was not in pain and it was sudden. At 101 years, that is the greatest gift God could have given me," attested Cathy).*

Cathy and Ralph's favorite travels included: taking a paddle wheel boat cruise on the Mississippi River (ending with extra days in New Orleans), and a cruise to Alaska with a number of parishioners. "We tried to become motor home enthusiasts but circumstances kept interfering," exclaimed Ralph.


