
In the month of November, we celebrate THANKSGIVING Day. Let's all concentrate and meditate on this **Thanksgiving Prayer**:

**Programs:**



**Fr. Virgil Cordano Catholic Studies Chair at UCSB Department for Religious Studies**

Dear Brother Knights, did you know that the University of California at Santa Barbara has an endowed chair in the Department for Religious Studies named for the beloved Fr. Virgil Cordano of our local Mission parish? Did you also know that having an endowed chair specifically for Catholic study at a public university (UCSB) is a rare occurrence? If you Google "Catholic Study" you will find several pages of universities with Catholic study programs, but these are all private schools, most associated in some way with the Catholic Church. Well perhaps you did know these facts, but did you know that the very existence of the endowed chair at UCSB can be directly attributed to one of the Knights of our Council 5300, Brother Chuck Burke (PGK, deceased) and his wife Harriet Burke?

It was the vision, determination, persistence and the contribution of personal real estate property to UCSB by the Burke's that created the circumstances that attracted a \$1 million pledge from Charles R. Schwab in 2001 which created the Fr. Virgil Cordano Catholic Studies chair. Quoting Fr. Virgil, "The program's aim will be to foster exploration of the historical, cultural, and sociological backgrounds of Catholicism in order to promote mutual understanding among people of different beliefs and cultures." Such a study program is unique at a public university because it examines a religion and its influence, impact and effect on our modern world, but without the aegis of undue influence from the governing body of that particular religion.

In addition to the Catholic Studies program at UCSB in the Department of Religious Studies, there are the Buddhist Studies, the Center for Middle East Studies, the Center for Sikh and Punjab Studies and the Walter H. Capps Center for Study of Ethics, Religion and Public Life. Combined together, these study centers provide an environment for examination of religions and how they shape and determine how we behave with our fellow humans in this world.

Just in case you are interested, here are several course offerings in Catholic Studies for this Winter quarter at UCSB:

Winter 2008

RS 24: Teachings of Jesus in Comparative Perspective (Thomas):

Exploration of key interpretations of the life and teachings of Jesus, and analysis of the sources from which these are reconstructed, in historical, comparative, and contemporary perspectives.

RS 137: Gnosticism and Manichaeism (Thomas):

Study of Gnostic and Manichaean religions as philosophical and ritual systems, as book religions, and in their interrelations with Christianity, Judaism, Zoroastrianism, and Platonism.

RS 138A: Church, State, and the Construction of Orthodoxy (Taves):

The course surveys the emergence and development of the Roman Catholic Church as an institution with particular attention to the ways in which church leaders defined, maintained, and transmitted a distinctively Catholic understanding of Christian orthodoxy.

And yes, these courses do not look like an advanced Baltimore Catechism to me either, but then I think that this is the idea; to have bright people, Catholic and non-Catholic studying aspects of Catholicism so that everyone comes out with a little better understanding.

Well, I hope that I interested you a little in the accomplishments of Chuck Burke, fellow Knight of Council 5300, and his wife Harriet. If you are interested in the UCSB Religious Studies programs,

you can explore the website at <http://www.religion.ucsb.edu/> Chuck Burke had an even bigger dream about the Knights of Columbus and his efforts to establish the Fr. Virgil Cordano Catholic Studies chair at UCSB, but I will save that for some future discussion.

**New Stem Cell Method Could Ease Ethical Concerns**

Two teams of scientists are reporting today that they turned human skin cells into what appear to be embryonic stem cells without having to make or destroy an embryo — a feat that could quell the ethical debate troubling the field.

All they had to do, the scientists said, was add four genes. The genes reprogrammed the chromosomes of the skin cells, making the cells into blank slates that should be able to turn into any of the 220 cell types of the human body, be it heart, brain, blood or bone. Until now, the only way to get such human universal cells was to pluck them from a human embryo several days after fertilization, destroying the embryo in the process.

The reprogrammed skin cells may yet prove to have subtle differences from embryonic stem cells that come directly from human embryos, and the new method includes potentially risky steps, like introducing a cancer gene. But stem cell researchers say they are confident that it will not take long to perfect the method and that today's drawbacks will prove to be temporary.

Researchers and ethicists not involved in the findings say the work should reshape the stem cell field. At some time in the near future, they said, today's debate over whether it is morally acceptable to create and destroy human embryos to obtain stem cells should be moot.

"Everyone was waiting for this day to come," said the Rev. Tadeusz Pacholczyk, director of education at the National Catholic Bioethics Center. "You should have a solution here that will address the moral objections that have been percolating for years," he added.

The two independent teams, from Japan and Wisconsin, note that their method also creates stem cells that genetically match the donor without having to resort to the controversial step of cloning. If stem cells are used to make replacement cells and tissues for patients, it would be invaluable to have genetically matched cells because they would not be rejected by the immune system. Even more important, scientists say, is that genetically matched cells from patients will enable them to study complex diseases, like Alzheimer's, in the lab.

Until now, the only way to get embryonic stem cells that genetically matched an individual would be to create embryos that were clones of that person and extract their stem cells. Just last week, scientists in Oregon reported that they did this with monkeys, but the prospect of doing such experiments in humans has been ethically fraught.

But with the new method, human cloning for stem cell research, like the creation of human embryos to extract stem cells, may be unnecessary.

"It really is amazing," said Dr. Leonard Zon, director of the stem cell program at Harvard Medical School's Children's Hospital.

And, said Dr. Douglas Melton, co-director of the Stem Cell Institute at Harvard University, it is "ethically uncomplicated."

For all the hopes invested in it over the past decade, embryonic stem cell research has not yet produced any cures or major therapeutic discoveries. Stem cells are so malleable that they may pose risk of cancer, and the new method of obtaining stem cells includes steps that raise their own safety concerns.

Still, the new work could allow the field to vault significant problems, including the shortage of human embryonic stem cells and restrictions on federal funding for such research. Even when scientists have other sources of funding, they report that it is expensive and difficult to find women who will provide eggs for such research.

The new discovery is being published online today in *Cell*, in a paper by Shinya Yamanaka of Kyoto University and the Gladstone Institute for Cardiovascular Disease in San Francisco, and in *Science*, in a paper by James Thomson and his colleagues at the University of Wisconsin.

While both groups used just four genes to reprogram human skin cells, two of the four genes used by the Japanese scientists were different from two of the four used by the American group. All the genes in question, though, act in a similar way – they are master regulator genes whose role is to turn other genes on or off.

The reprogrammed cells, the scientists report, appear to behave exactly like human embryonic stem cells.

"By any means we test them they are the same as embryonic stem cells," Dr. Thomson says.

He and Dr. Yamanaka caution, though, that they still must confirm that the reprogrammed human skin cells really are the same as stem cells they get from embryos. And while those studies are underway, Dr. Thomson and others say, it would be premature to abandon research with stem cells taken from human embryos.

Another caveat is that, so far, scientists use a type of virus, a retrovirus, to insert the genes into the cells' chromosomes. Retroviruses slip genes into chromosomes at random, sometimes causing mutations that can make normal cells turn into cancers.

In addition, one of the genes that the Japanese scientists insert actually is a cancer gene.

The cancer risk means that the resulting stem cells would not be suitable for replacement cells or tissues for patients with diseases, like diabetes, in which their own cells die. They would, though, be

ideal for the sort of studies that many researchers say are the real promise of this endeavor — studying the causes and treatments of complex diseases.

For example, researchers want to make embryonic stem cells from a person with a disease like Alzheimer's and turn the stem cells into nerve cells in a petri dish. Then, scientists hope, they may be able to understand what goes awry in Alzheimer's patients when their brain cells die and how to prevent or treat the disease.

"The best thing about being a Knights of Columbus member is the opportunity to serve," stated Coyne.

Paul recalled proudly three of his goals which were achieved during his Columbian Year as GK:

- The 25th Anniversary Program and Dinner on May 25, 1987;
- A successful Civic Officials Night;
- The Best Fiesta Booth Gross Income.

Paul's response to why men should consider becoming a Knight is, "Involvement in the church and the community and fraternity of Brother Knights." Paul recalls there were 215 members of Council 5300 while serving as GK.

Paul also recalled with pride the officers and directors who served during his year as GK: Richard Martinez, DGK; Tom Quinn, Chancellor; Fausto Navarro, Warden; Dan Bunke, Recorder; John Kusick, Treasurer; Wayne Rascati, Financial Secretary; Pablo Herrera, Larry Stigney, Don Aubrey, Trustees; Bob Montgomery, Program Director; Stan Nowak, Membership, Larry Miller Church; Dan Bunke, Community; Mario Bertuzzi, Council; Ken Kuether Family and Tom Quinn, Youth.

Paul and his sisters Carol and Priscilla attended St. Peter's Grade School in Cambridge and Wayland High School. Paul graduated from Boston College in 1965 majoring in Finance/Accounting. Carol resides in Arlington, MA. and Priscilla in Williamsburg, VA.

Paul met Roberta Ann Barry at a CYO Youth Group event in 1956. On October 15, 1960, the couple was married at St. Zepherin Catholic Church with Rev. F. Hobbs officiating.

Thirteen years later Paul & Roberta moved to Santa Barbara with their four children, Diane, Paul Jr., Michael and Donna.

Roberta and her twin-brother Wilbur and sisters Joanmarie and Cheryl were born in Cambridge. The sisters live in Scituate and Pascoag, MA. and her brother in Huntington Harbor, Calif. Wilbur is a member of KC 5300.

Paul started work at Raytheon in 1955 in Wayland and served as an Engineering intern while at Boston College and later in the accounting department for 40-years in Massachusetts and Goleta. "Persistent

attention to goals," remarked Paul were the keys to his success in his professional career.

Paul served with the U.S. Naval Reserves from 1954-65 and was on active duty in 1961-62 during the Cuban crisis in Guantanamo Bay. While residing in Holliston, MA., Paul was president of the Jaycees and was elected as an official with the town's Finance Committee.

Members of St. Raphael's Church since 1973, the Coynes noted the best thing about being parishioners is the warm friendship of parishioners. Paul keeps busy at the parish as a Eucharistic Minister, member of the Sociable Seniors and a gardener taking care of all the many colorful roses at St. Raphael's, many he planted in the past several years. There are about 75 roses on the church grounds which he prunes once a year and once a month he fertilizes them, gratis. With the gopher problems he now uses a gopher cage when he plants a new rose. These are circled around the base, a foot down so that protects the roots.

Paul and Roberta recognized Father Stephen Noel Downes as an extra-special pastor/priest. "Msgr. Steve is a wonderful representative for the church. He celebrated the Mass for two children and baptized four grandchildren. He's humble in nature and a joy to be with," they expressed.

They have lots of happy memories with former priests of the parish especially Father Jack Stoeger, Msgr. Stephen Noel Downes, Father Antonio Cacciapuoti, Father Charles Hofschulte and Father Vaughn Winters.

Since 1990, Paul & Roberta have taken seven trips to Europe. In 2006, they spent six weeks in Ireland and this year visited Copper Canyon, Mexico.

Countries on their travels also have included England, Scotland, Wales, Mexico, Alaska, Spain, Portugal, France, Germany, Switzerland, Greece, Canada, Hawaii. The Coynes have also taken a Carribean Cruise.

Over the years, besides her motherhood responsibilities, Roberta has been and is a Docent at the Santa Barbara Mission, has been a Pink Lady at Goleta Valley Community Hospital, a bridge player (2-3 times a week), an Administrative Assistant for

the Building Trades (26 years), a Eucharistic Minister to the Sick at St. Raphael's, a member of the Woman's Service Club of Goleta, a member of Friendship Force of Santa Barbara and a member of Scouting.




