**Spiritual Thoughts on Presidential Election**

I have heard from a lot of upset people about the results of our recent presidential elections. And it all sounds like loss of hope.

As everyone is well aware, this year has been declared the year of Saint Paul by the Vatican. To counter this feeling of hopelessness, solace can be found in the words of Saint Paul. I present to you an excerpt from the handbook, "**Praying with Saint Paul**" by Magnificat Publishing, USA. Edited by Fr. Peter John Cameron, O.P., this handbook contains daily reflections on the Letters of Saint Paul.

*From the daily reflection entry in "Praying with Saint Paul" for August 20<sup>th</sup>:*

**"The Great Grace of Hope"**  
**By Father Harry Cronin C.S.C.**

"We have heard of your faith in Christ Jesus and the love that you have for all the holy ones

because of the hope reserved for you in heaven. Of this you have already heard through the word of truth, the gospel that has come to you." (Col. 1; 4-5)

"The first victim of any disaster is hope - whether that disaster is natural or man-made. Whenever things go monstrously wrong, the first casualty is always hope. It is fragile, like rare cut glass. We can lose it easily. Saint Paul tells us that, for those who follow Christ, there is someone who protects and saves our hope: the Father of Jesus. Saint Paul tells us that our hope is safe with God. It is well beyond any damage that can be afflicted by human disaster or natural cataclysm. God truly holds our hope and guards it."

"The Gospel records only three times when Jesus raised from the dead. Each time He did so, He used words. Simple words. He only spoke. He called - probably shouted - at Lazarus to come out of the grave. He told the daughter of Jairus just to "get up." And He told the son of the widow Naim to "rise." Jesus always used words when He spoke to the dead. He called the dead back to life with the sound of His own human voice. When Paul says that we have heard this hope, he is making an important statement. Hope is always something we hear. It becomes a cycle. When we hear it, we experience it, and when we experience it, we speak it. We cannot hope because of what we think or what we read. We hope because of what is said to us - by someone."

"Of course, it makes a great difference who it is who speaks hope to us. It has to be someone who has hope, someone who has found hope in his life. We must hear hope from one of those rare persons who have looked unflinchingly at the despair and destruction of the world and said: that is not all there is. There is something beyond, and that "something" is hope."

"So let us speak hope, with strong words."

### **Donate Life Rose Parade Float To Feature Joe Darga, KC Treasurer**

Joseph Ronald Darga, Treasurer of the Knights of Columbus, Council 5300, who received a transplanted heart six years ago will be one of 26 people riding down Colorado Boulevard in Pasadena atop the Donate Life Rose Parade Float "Stars of Life" on New Years Day. If you watch the parade look for the float and spot Darga on it as he will be waving to you all.

The 74-year old member of the Knights of Columbus and parishioner of St. Raphael Church joins other organ donors, recipients and family members from around the country in helping Donate Life raise awareness of the critical need for people to become donors of organs, eyes and tissue.

The float riders range in age from 17 to 74 and hail from 16 states. Their experiences are varied. One gave a kidney to a fellow DMV employee he had never met. Seven parents gave other children a chance at survival by donating organs from sons and daughters whose lives were cut short. A 24-year old New York woman will be on hand to honor a Nebraska donor whose liver saved her when she was just 14-months old. Last year Karen Cottriel and Jim Boysel, the parents of Jake Boysel - a local 12-year old boy whose organs were donated after he was hit and killed by a vehicle in 2006 - placed a rose on the float in honor of their son.

The float effort is organized by Donate Life America member OneLegacy, a nonprofit organ and tissue donation agency serving the greater Los Angeles area.

Darga, a KC member since 1999 and a parishioner at St. Raphael since 1970, lived with cardiomyopathy for seven years, eventually becoming too weak to eat and seeing his weight

drop to 103-lbs. His only chance at survival was to receive a transplanted heart. A family from Stockton saved his life by agreeing to donate the organ of a loved one.

"All I know is he was a 42-year old Hispanic man from Stockton," Mr. Darga said when asked what he knew about the donor.

"His family moved back to Mexico and I can't contact them. I'm told he fell from a lofted area and had a head injury," stated Darga.

"Receiving that gift of life, a new heart is the most wonderful event that has ever happened in my entire life. During my recovery, I felt I must do something in return for this very special gift," exclaimed the U.S. Navy veteran. He continued, "In 2003, I was trained as an Ambassador for OneLegacy. I had a new perspective on life, living and giving and a mission to promote donor awareness in my community. Since then, I have shared my story at numerous high schools, local organizations, St. Raphael's Church, hospitals and community events."

A single donor's organs can save up to eight lives, said Darga, who was named OneLegacy's Ambassador of the Year in 2005 for his efforts in promoting the Donate Life mission in Santa Barbara County. His donor, he said, saved four people. "I got his heart, a woman in Cathedral City got his lungs and two men in northern California got his kidneys," pointed out Darga.

The former Burroughs Corp. Field Engineer (1959-1981) explained, "My health has been good since the transplant, although I must continue to take drugs that suppress my immune system so as to stave off my body's possible rejection of the heart." Darga boasted, "Each morning, I awake and thank God for this new life and also the wonderful family in Stockton for saying "YES" to donation. I am now proud to say I'm the only half Polish, half German Knight in Southern California with a Mexican heart."

Darga noted to sign up as an organ and tissue donor, visit [www.donatelifecalifornia.org](http://www.donatelifecalifornia.org).

There are two Transplant Support Groups in Santa Barbara for those who are waiting or have received a transplant. One meets every 4th Wednesday at 5:30 p.m. and one on the 2nd Saturday of the month at 9 a.m. for breakfast. Anyone interested in attending can call Darga at 964-3264. He added, "Anyone renewing or getting a California driver's license for the first time can also check a box that adds their name to the organ donor registry. Anyone who adds their name to the registry by either means is urged to speak to their next of kin about their decision, which once made is considered first person consent that next of kin cannot override."

native of Sacramento has served as Recorder in 2006, Warden in 2007 and Advocate in 2008. He is also a Worthy Scribe for the 4<sup>th</sup> Degree and participates in the 4<sup>th</sup> degree Color Corps on occasion. "Supporting the Church in small ways is the best thing about being a KC member," stated Ed. One of his reasons for becoming a KC member and a goal he wishes to achieve as a Knight is to support the church.

Ed enjoys active KC involvement as he can be found at Council 5300 socials at the St. Raphael Parish Hall. He enjoys cooking spaghetti for Sam Alfano for the St. Joseph's Italian Dinner and monthly breakfasts with Jim Bradbury and Jose Meza. He also assists Chris Arnoult for the Blood Drives and Bill McNamara with Christmas Card sales.

"Support the Church, grow spiritually within the Church and being active in the parish community as a Catholic," are Ed's recommendations why other men should consider becoming a member of the Knights of Columbus. He continued, "Becoming a 4th Degree at Visalia's Exemplification Ceremony is a KC program that stands out as a cherished remembrance never to be forgotten."

Born on August 28, 1966, his parents lived in Sacramento, CA. His father John hailed from Yellow Pine, Alabama and was a train dispatcher for the Southern Pacific Railroad. His mother Concetta's birthplace was Rome, Italy. She immigrated to the United States in 1953. Upon the death of his father, both he and his mother moved to Memphis, Tennessee. In 1972 they moved to Santa Barbara and became parishioners of Our Lady of Sorrows. Ed's fond recollections are of Father John Mossi, SJ, who trained him to be an Altar Server, Father Martin Brewer who was the celebrant for his First Communion and Confirmation and also his mother's funeral in 2002. Ed has been a member of Our Lady of Sorrows from 1977-83 and 2003-present.

Ed's current parish involvements include being a Lector at the 9:00 and 10:30 AM Masses, a Eucharistic Minister and mingling with the parishioners after Mass for coffee and doughnuts. His education started at Notre Dame Grade School, continued at Bishop Garcia Diego High School and earning a BS in Engineering/Physics at Westmont College in 1989. Ed noted that he spent many hours studying and taking exams in the Physics Building which burned down in the recent Tea Fire in Montecito/Santa Barbara. His interest in Software Engineering was encouraged during his period of summer research in 1987 in the Physics Building.

Ed is looking forward to two upcoming events: his 1st and 4th Grade teacher, Ms. Sue Labadie is retiring this year from Notre Dame School after 40-years of teaching and also his 25th High School Reunion in 2009.

Working for Raytheon EW in Goleta for 18 years, nine in Manufacturing and nine in Software Engineering, has been Ed's professional career. He credits continuing education, luck, doing the best he can and teamwork as keys to his success to date.
